North Monterey County Middle School is dedicated to helping our students complete the transition from elementary to high school. As a Community of Caring school, our ongoing goals are to reinforce the values of respect, responsibility, caring, trust and family. The school will utilize educational methods that reflect a constantly changing, diverse, and highly technological society. We offer curriculum and programs for our students with a strong emphasis on the academic and self-management skills they will need to meet and exceed academic expectations at North Monterey County High School and beyond.

A new gymnasium was constructed in and operational as of 2001. The school also provides adequate physical education equipment for safe recreational activities. Sports fields and the track have been improved and updated this school year (2008-2009) and a climbing rock wall was added in the gym. Our school landscaping and beautification projects have continued this year, enhancing our school's appearance. The school is cleaned and maintained daily by a full time custodial staff.
